

# Terms and Conditions

## Price

- Main Tour
  - \$5,790 per participant in double occupancy, excluding international flights
  - +\$1,400 single room supplement
- Santorini Extension
  - \$3,640 per participant in double occupancy
  - +\$1,850 single room supplement

## Included in Price

- Shared double room accommodations
- Meals as indicated in the itinerary, including house wine with dinner
- Transportation and entrance fees to all sights, museums, and activities per the itinerary
- Daily accompaniment and on-site guiding from Sofia Travel staff
- Hotel portage for one suitcase per person
- Airport-hotel transfers for travelers on Sofia Travel arranged group flights
- All taxes, fees, and gratuities

## Not Included in Price

- International flights and all associated costs
- Airport-hotel transfers for travelers making their own air arrangements
- Meals not listed in the itinerary
- Supplemental fees for single room accommodations (see above)
- Travel insurance
- Excess baggage
- Individual transfers or additions and changes to the listed program
- Drinks in addition to wine at dinner, snacks, and special meal requests
- Laundry services, internet or telephone fees at hotels, and items of a personal nature

## Reservation Deposit & Final Payment

A non-refundable, non-transferable deposit of \$800 per tour and \$1,200 per extension is required at the time of reservation to guarantee a place on the tour. The full balance is due December 6, 2024.

## Activity Level

Travelers should be able to enjoy walking unassisted for an extended period of time without resting, be sure-footed on uneven surfaces, enter and exit a moored boat, and walk up and down inclines and multiple flights of stairs easily and without assistance. Due to its unique position on the rim of an ancient volcano, the hotel in Santorini includes multiple flights of stairs between the hotel entrance, the rooms, and the breakfast area. Travelers are responsible for carrying their own carry-on luggage at all times.

## Flights

Flights arranged by Sofia Travel are subject solely to the policies of the respective airlines, and seating arrangements cannot always be guaranteed until time of check-in. Sofia Travel is not responsible for any expenses incurred due to flight cancellations or changes. Travelers making their own flights may need to pay for airport-hotel transfers if arrival and departure times do not match group flight times.

## Luggage

Limit of one suitcase and one carry-on per person. Travelers are solely responsible for complying with all airline baggage weight and size limits. Hotel portage is included for one suitcase per person. Carry-on luggage will be the responsibility of passengers at all times.

## Cancellation Fees

Sofia Travel must receive all cancellation and refund requests in writing. Registration and extension deposits are non-refundable and non-transferable. Cancellations received on or after December 7, 2024 will carry a 50% cancellation penalty, cancellations received on or after March 15, 2025 will carry a 75% cancellation penalty. No refunds will be given on or after April 26, 2025. All cancellation fees are based on the total tour price including all flights, extensions, and additional costs.

## Insurance

Travelers are highly recommended to purchase travel insurance. Information will be sent with your Texas Exes confirmation. Travelers are fully responsible for understanding and agreeing to all stated terms and conditions of any third party insurance policy they may choose to purchase and absolve Sofia Travel of any responsibilities, payments, or refunds regarding travel insurance.

## Documentation & Entry Requirements

U.S. citizens require a valid passport. The traveler assumes complete and full responsibility for, and hereby releases Sofia Travel from, any duty of checking and verifying any and all passport, visa, vaccination, health screening, or other entry requirements for each destination, and all safety and security conditions during the proposed travel. Please note that customs agents often require passport validity for six months from the return date of travel. Assuring passport validity for travel is the sole responsibility of the individual traveler.

## Statement of Responsibility

Sofia Travel (ST) or the Texas Exes (TE) shall not be held responsible for any wrongful or negligent acts or omissions or defaults by any supplier or other party not directly owned or controlled by ST/TE or by the failure of any equipment operated by any such supplier or other party. ST/TE shall not be liable for any loss, injury, or damage to person, property or otherwise, in connection with any accommodations, transportation, or other services, resulting directly or indirectly from any acts of God, dangers incident to the sea, fire, breakdown of machinery or equipment, acts of government of other authorities, wars whether or not declared, hostilities, civil disturbances, strikes, riots, thefts, pilferages, epidemics, pandemics, quarantines, medical or customs regulations, defaults, delays or cancellations of or changes to itineraries or schedules. Neither ST/TE nor any of its affiliates or subsidiaries shall be or become liable or responsible for any additional expenses of liability sustained or incurred by the tour member as a result of any of the aforementioned causes. ST/TE is released from any and all claims and causes of action that a tour participant may hold for personal injury, property damage or wrongful death, arising out of participation in tour activities. ST/TE does not have special knowledge regarding the hazards of medical procedures in any location, suitability of medical travel for any person, financial condition of any supplier, unsafe conditions, health hazards, weather hazards, political conditions, or climate extremes at locations to which you may travel. ST/TE responsibility to passengers carried in vehicles and aircraft for transfer and excursions and tours is governed by the laws of the respective countries in which the tours take place and no other country. All claims against ST/TE must be made within 30 days of travel and are

subject only to the jurisdiction of the courts of the country in which the cause of action arises. The right is reserved to substitute hotels and to alter itineraries. Individual or group cancellations due to factors outside of ST's control will be subject to the listed cancellation fees. All tickets and vouchers issued for transportation and services are subject to the terms and conditions under which such transportation and services are provided to the participant by the owners or contractors. Venue for any disputes is Travis County, TX. This contract shall be governed by the laws of the State of Texas.
